Privacy policy

Introduction

This document constitutes the Privacy Policy for the website of: <https://explomet.pl>
The Privacy Policy consists of two parts:

PART I „Cookies files” – applies to all Users using the website of: <https://explomet.pl>

PART II „Personal data” – applies only to those Users whose personal data is processed by the Administrator of the website.

PART I „Cookies files”

1. Cookies files (so-called Cookies) are IT data, in particular text files, which are stored on the User's end device (device on which the web browser is located) and are intended for the use of the website of <https://explomet.pl>. Cookies usually contain the name of the website they come from, the storage time on the end device and a unique number.
2. We explain that we only collect information contained in cookies on the website, but we do not collect any other data from you on your device. Please be advised that the portal does not use the so-called tracking cookies, i.e. files that enable spying on users.
3. By using our website, you consent to our use of Cookies for the purposes described in this document. We remind you that you can change the settings of Cookies at any time using the settings of your browser.
4. On our website <https://explomet.pl> we use Performance Cookies, i.e. to collect information about how to use our website to make it work better, and Functional Cookies, i.e. to “remember” about user settings (e.g. language, size fonts). Therefore, we use cookies for the following purposes:
 - a) adapting the content of the website to the user's settings regarding the use of websites. This makes possible to recognize your device and properly display the website, tailored to your individual needs,
 - b) ensuring greater security of using of our website,
 - c) creating statistics that are the basis for the analysis of how users use websites.
5. We use two types of Cookies on our website:
 - a) session cookies, i.e. temporary files that are stored on the user's end device until logging out, leaving the website or turning off the web browser,
 - b) persistent cookies, i.e. files that are stored on the user's end device for the time specified in the parameters of these files or until they are deleted by the user.
6. We explain that the web browser very often allows cookies to be stored on the user's end device by default. We remind you that you can change your Cookie settings at any time. These settings can be changed, for example, in such a way as to block the automatic handling of Cookies in the web browser settings or to inform about their every posting in the user's device.
7. You can also clear your browser cache on your own, so that all Cookies will be deleted.
8. Detailed information on the possibilities and methods of handling with Cookies is available in the settings of your web browser (i.e. Chrome, Firefox, Internet Explorer).

PART II „Personal data”

9. Please be advised that in accordance with the provisions of the Regulation of the European Parliament and of the Council (EU) No. 2016/679 of 27 April 2016 (so-called GDPR), the administrator of your personal data is: ZTW EXPLOMET Gałka, Szulc sp.j., ul. Oświęcimska 100H in Opole, e-mail: biuro@explomet.pl

10. Your personal data obtained while using the website of <https://explomet.pl> may be processed for the following purposes:

a) for purposes resulting from the legitimate interests pursued by the Administrator, including for statistical and analytical purposes of the Administrator, where the Administrator's legitimate interest is the possibility of making analyzes and statistics of activities carried out by him - i.e. pursuant to art. 6 sec. 1 lit. f) GDPR,

b) in order to answer the question sent by e-mail or via the contact form on our website. The processing is then based on your consent expressed in the Contact tab - i.e. pursuant to art. 6 sec. 1 lit. a) GDPR.

11. Your data will be processed until the consent is withdrawn or an objection is raised, and in the event of inquiries via the Contact tab - if the appointment date or notary services are not arranged, your personal data will be deleted after a maximum period of 12 months.

12. In the case of data processed on the basis of consent (Article 6 (1) (a) of the GDPR), you have the right to withdraw your consent at any time without giving any reason. Withdrawal of consent does not affect the lawfulness of data processing that was carried out before its withdrawal. All you need to do is write to the following e-mail address: biuro@explomet.pl: "I withdraw my consent to the processing of my personal data for processing inquiries by e-mail". Withdrawal of consent does not affect the lawfulness of the processing of your personal data that we have made before its withdrawal.

13. Your personal data may be made available to entities that provide IT services for my company in the scope of personal data entrusted to them.

14. You have the right to access your personal data, the right to rectify it, limit processing, the right to object, the right to transfer data and the right to delete your data (the right to be forgotten).

15. You also have the right to lodge a complaint with the President of the Personal Data Protection Office if you feel that the processing of your personal data violates the provisions of the GDPR.
